

## **CLUB MALUA MEMBERS BADGE DRAW – TERMS & CONDITIONS**

The CLUB MALUA MEMBERS BADGE DRAW consists of an opportunity to win cash every Wednesday and Saturday at 7:45pm in the 'CLUB MALUA MEMBERS BADGE DRAW' promotion. This promotion will remain active whilst advertised within the venue.

The draw at 7:45pm is for the Member's Jackpot starting at \$20,000.00, when one financial member will be drawn from the membership database. Should the member be able to present themselves in person within 4 minutes, they win the full jackpot. Should the drawn member not be on site to claim the prize, the jackpot increases by \$500.00 every draw. A second chance draw will take place at 8pm for \$250.00.

### **1. GENERAL TERMS & CONDITIONS**

- 1.1. Directors, Management, Staff & Promotional Contractors of Cabramatta Bowling and Recreation Club Ltd are ineligible to enter as per the board adopted Promotional Policy.
- 1.2. Open to all financial members of CLUB MALUA over the age of eighteen (18) years who are not suspended or cited from the venue.
- 1.3. In unforeseen circumstances management have the right to cancel or postpone the cash draws at any time.
- 1.4. To claim any prize, members must produce their membership card as proof of current membership and/or one other form of valid identification. Valid ID includes Driver's License, Proof of Age Card & Pensioner Card.
- 1.5. All members financial or pending approval as per Cabramatta Bowling and Recreation Club Ltd's IGT membership system as at 7:30pm on the day of the draw will be eligible for the draws.
- 1.6. The advertised Jackpot prize money will be paid to the eligible winner with up to \$5,000.00 in cash with any amount exceeding \$5,000.00 by a crossed cheque made out to the winner (or by EFT if the winner so requests.) The full prize amount can be paid in this manner if desired. If EFT payment method is chosen, this will be completed within seventy two (72) hours of the draw.

### **2. CLUB MALUA MEMBERS BADGE DRAW TERMS & CONDITIONS**

- 2.1. A random number generator (membership program) is programmed to draw a membership number from the current financial and pending approval club membership listing, as of 7am on the date of the draw.
- 2.2. The Draw will commence on the 7:45pm at CLUB MALUA . The promotion will run every Friday.
- 2.3. If the member is not present the Jackpot will increase by \$500.00 to a maximum of \$40,000.00. The second chance draw of \$250.00 will not increase and the prize money will be forfeit, if not claimed.
- 2.4. The holder of the membership number drawn must be signed into the Club at the time of announcement, they then have four (4) minutes to claim their prize. They must present their membership card or acceptable identification to claim the prize.
  - 2.4.1. If the Member is not present and signed in via the reception at the time the draw takes place, they will not be eligible for the prize.
- 2.5. The maximum jackpot prize is \$40,000.00. If the jackpot is not claimed on the night, the club will conduct a major draw and split the jackpot amount into 8 equal amounts of \$5,000.00. The members will have the opportunity to swipe their membership card at the membership terminal to receive an entry ticket for the jackpot draw. All entry tickets must be placed in the barrel provided which will be clearly marked with the promotion name.

### 3. CLUB MALUA MAJOR DRAW TERMS & CONDITIONS

- 3.1. The 'CLUB MALUA MAJOR DRAW' will only apply if the jackpot reaches \$40,000.00 and is not claimed on the night.
- 3.2. The CLUB MALUA MAJOR DRAW gives all members an opportunity to swipe their membership card at the membership terminal and receive one entry ticket for the major draws. All tickets must be placed in the barrel prior to the major draw. The club will conduct 8 draws of \$5,000.00.
- 3.3. The member must be on site when prize is drawn and claim the prize within four (4) minutes. If the prize is not claimed within four (4) minutes another entry is drawn. There will continue to be draws until the prize is won.
- 3.4. The CLUB MALUA MAJOR DRAW prize winner is selected blindly by the promotional staff member drawing a ticket from a Perspex barrel or box.
- 3.5. There will be no second chance draw of \$250.00 on the day, when the jackpot reaches \$40,000.00.

### 4. GENERAL TERMS & CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

- 4.1. The Club's premises are as determined by the Club in its discretion and comprise all areas within the main club building (excluding function rooms if in use for a private event at the time of the draws). The Club's car parks does not form part of the Club's premises for the purposes of Club promotions.
- 4.2. The Club's promotional stand (for announcements of all draws) is determined by the Club in its discretion at the time of the draw.
- 4.3. The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.
- 4.4. The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.
- 4.5. The Club's decisions in relation to the promotion may be made by the Club's CEO or his delegate or delegates from time to time (who may but need not be a Club executive), including decisions in relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. The Club's CEO also may (but is not obliged to) appoint one or more scrutineers for a particular draw or draws or all draws or a prize process or all prize processes. Decisions by the Club's CEO, and subject to any countermanding decision by the Club's CEO also decisions by any such delegate or judge, are final. No such decision requires any consultation. No correspondence will be entered into in relation to any such decision.
- 4.6. Members wishing to be sure of entry should seek to complete transactions and to initiate ticket printing early, to reduce the risk of being excluded because of any shortage of service points or because of delay or crowding.
- 4.7. The Club is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members or in the completion of entries to the promotion or in seeking to attend any draw or to attend the process of selecting a winner.
- 4.8. Further, the Club is not responsible for members being located in areas within the Club's premises in which public address announcements are not able to be heard, nor for the audible integrity of those announcements.

- 4.9. A prize will not be awarded or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction.
- 4.10. The Club has no liability for acting on or promulgating any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.
- 4.11. Prizes are strictly not transferable or negotiable.
- 4.12. If the Club in good faith awards or pays a prize to someone appearing to the Club to be the prize winner, then to the maximum extent permitted by law that award or payment fully discharges the Club from all liability to the actual prize winner in relation to that prize.
- 4.13. Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting. The Club is not responsible for any such advice.
- 4.14. No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions.
- 4.15. These conditions cannot be varied for an individual member.
- 4.16. The Club determines the designated clock from which draws are timed.
- 4.17. A person by claiming or accepting a prize agrees that the Club may use their name, suburb, photograph, image and likeness for the purpose of promoting the Club and agrees to co-operate with the Club to allow their photo to be taken for those purposes.
- 4.18. Neither the Club nor any of its officers, employees, contractors or agents, has any liability for any loss or damage of any nature or for injury or death, sustained in connection with the promotion or any prize, except any minimum liability which cannot be excluded by law (if any).
- 4.19. All risks of loss of or damage to any prize consisting of a car or other goods, pass to the winner immediately the Club delivers the prize to the winner. It is strongly recommended that the winner make their own arrangements for all appropriate insurances in relation to a prize to take effect from the time of delivery, against loss or damage, claims by others and any other risk of concern to the winner.
- 4.20. Members will be notified of this promotion via the Club's advertising platforms, PA announcements, or by other means at the Club's discretion.
- 4.21. Pictures, descriptions or other representations of any proposed prize, are general and indicative only.
